RAMP – The following breeds must be examined on a ramp through all levels of conformation competition: Lagotto Romagnolo, Clumber Spaniel, English Springer Spaniel, Sussex Spaniel, Basset Hound, Cirneco dell'Etna, Kerry Blue Terrier, Bulldog, Chinese Shar-Pei, Chow Chow, Keeshond, Spanish Water Dog.

At the discretion of the judge, the following breeds may be examined on a ramp through all levels of competition: Nova Scotia Duck Tolling Retriever, American Water Spaniel, Boykin Spaniels, Field Spaniel, Welsh Springer Spaniel, Basenji, Grand Basset Griffon Vendeen, Norwegian Elkhound, Whippet, German Pinscher, Portuguese Water Dog, Standard Schnauzer, American Staffordshire Terrier, Irish Terrier, Soft Coated Wheaten Terrier, Staffordshire Bull Terrier, Finnish Spitz, Australian Cattle Dogs, Entlebucher Mountain Dog, Finnish Lapphund, Icelandic Sheepdog, Mudi, Norwegian Buhund, Polish Lowland Sheepdog, Puli, Norrbottenspet.

The following breeds may be examined on the ground, table or ramp: Miniature Bull Terrier.

Junior showmanship judges should follow the above.

Ramps may be used in emergency situations to examine any breed. (In all but emergency situations, the exhibitor has no recourse. Each Pee Wee unit consists of the child, their responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

A dog must be at least four months of age to enter the Pee Wee class.

All dogs entered must have the proper lead and collar.

A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.

Dogs that are allowed: AKC fully recognized, Miscellaneous Class breeds, PAL listings, FSS breeds, and All-American

A release must be signed by the child's parent or legal guardian. Pee Wee Release of Liability will be available at the show. A time and ring will be listed in the judging program.

The entry fee has been waived by the club. There is no cost for this event. Entries will be accepted on the day of the event.

The safety of the dog and child inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

Although the word "judge" will be used, this is designed to be a learning and mentoring experience. No Pee Wee will be "judged" but rather will be mentored with the age-appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored.

## SATURDAY & SUNDAY NOHS JUDGING

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers\*, household members and current assistants\*\* to professional handlers may not exhibit the dog in any NOHS competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.

- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.

- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.

- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.

- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.

- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.

- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

*\*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years*

Bred by Exhibitor Classes Divided, both Sexes: 6-12 Mos., 12 Mos. & Older Competition for Best of Breed Bred-by-Exhibitor will be held after the completion of each breed. The schedule for Bred-by-Exhibitor group time and judge will be published in the judging program. Competition for Best in Show Bred-by-Exhibitor will take place just prior to the regular Best in Show judging. Entry for Best of Breed Bred-by-Exhibitor is automatic for dogs & bitches that win first place in the regular Bred-by-Exhibitor Class. Throughout competition, dogs & bitches must be shown by persons eligible for the Bred-by-Exhibitor Class as defined in Chapter 3, Section 7, of the Rules Applying to Dog Shows published by The American Kennel Club. **Open Senior Class:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Master Class:** This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors Meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

Junior Handlers who win a third Novice Class with competition present after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the show, whichever is earlier.

Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes which have been approved to date by AKC, go online at [www.akc.org](http://www.akc.org).

Junior Handler's must include their AKC Junior Handler identification number on the entry blank. You may obtain your number by calling the AKC Event Records Department (919) 233-9767.

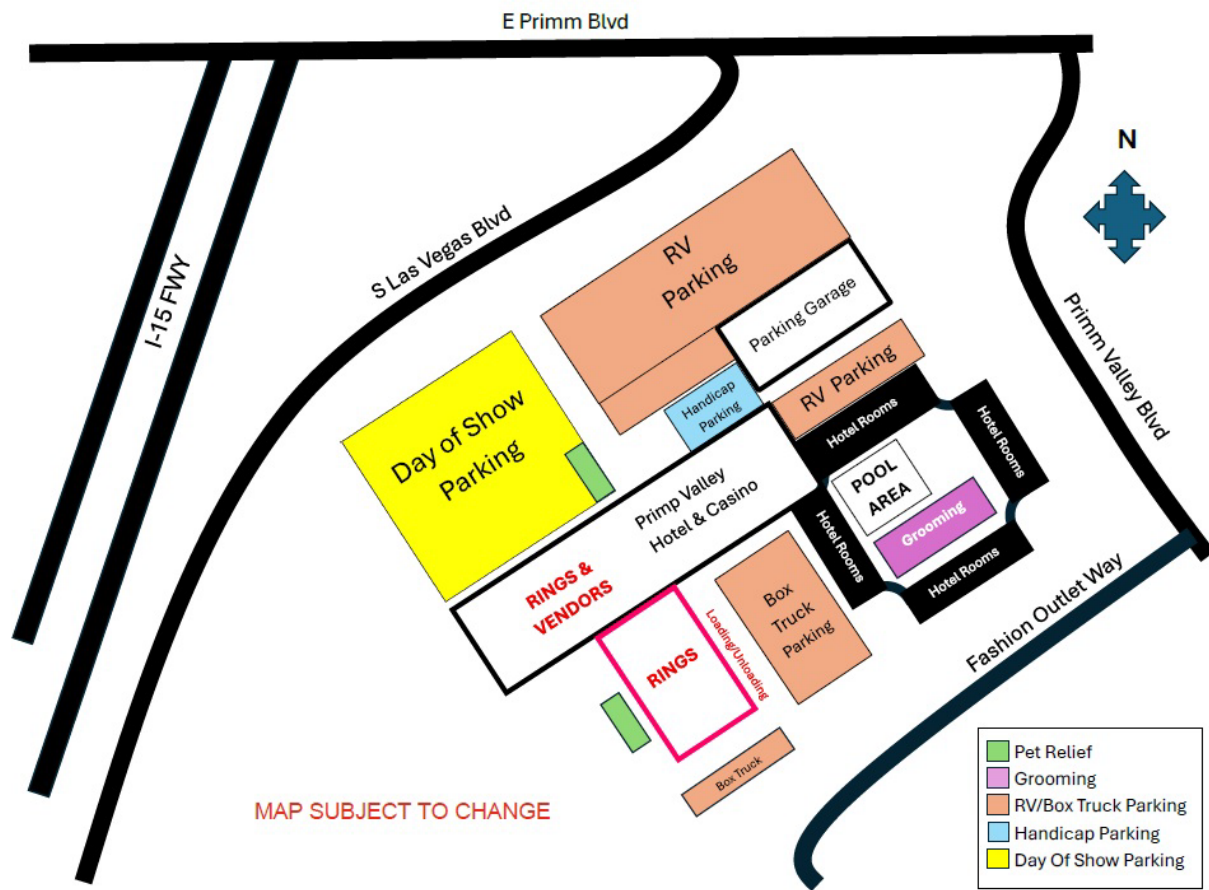

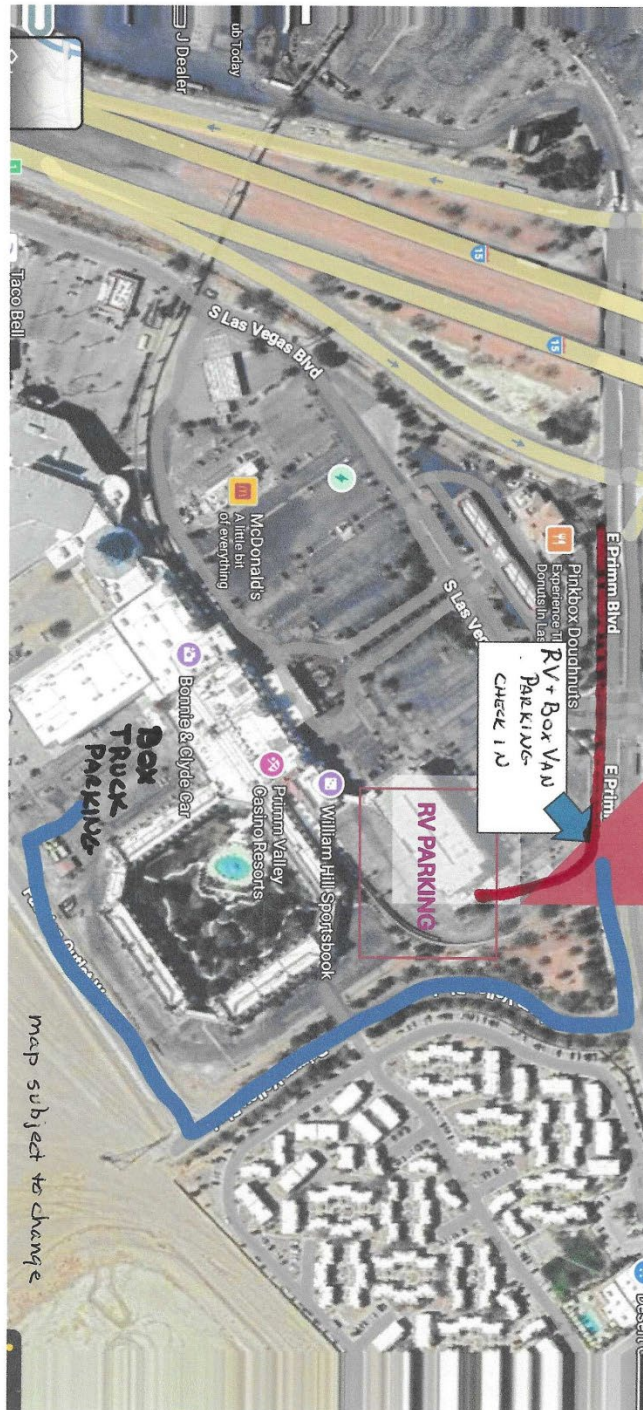

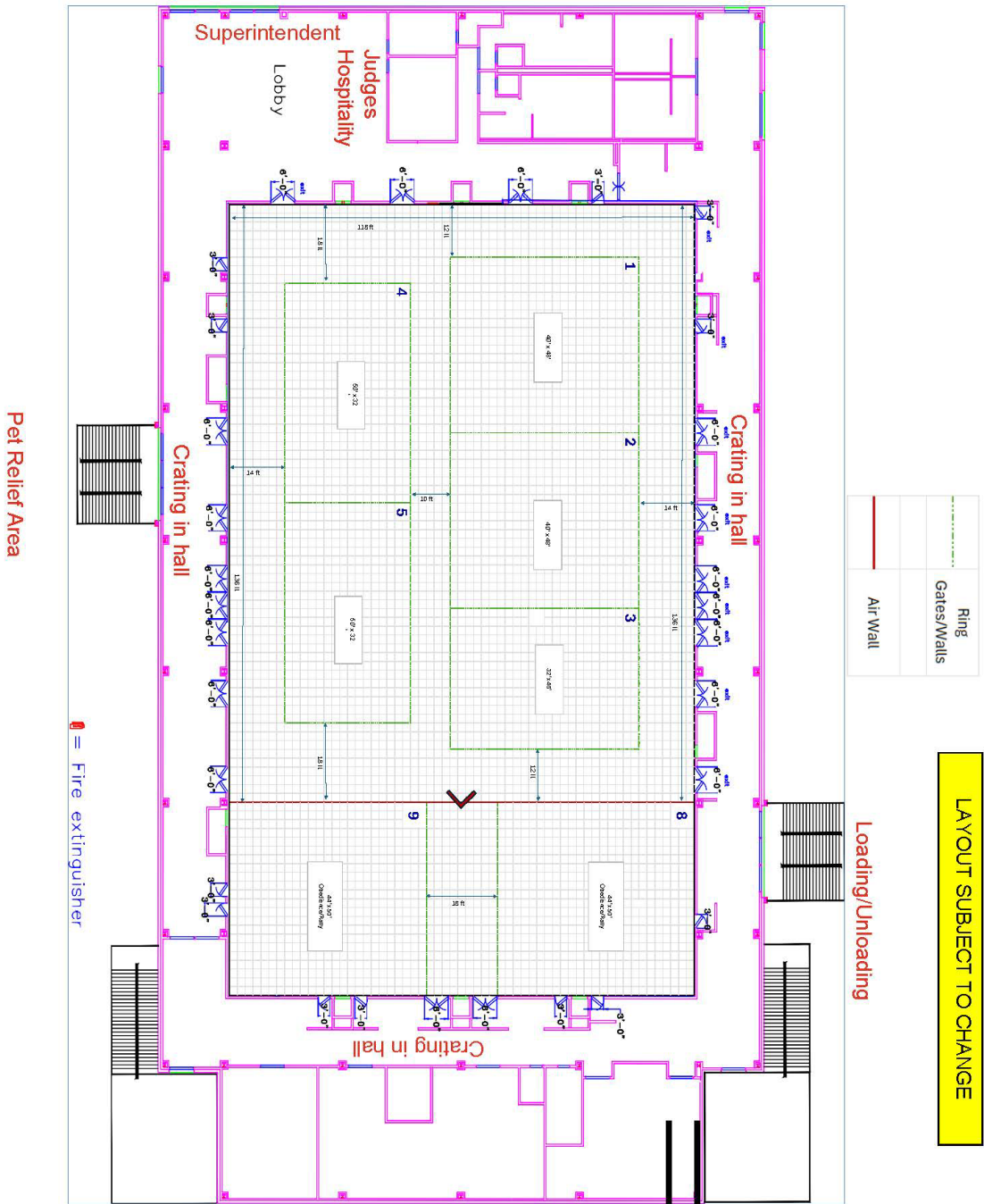

These values are evident across all aspects of the sport: conformation, performance, companion, and family dog activities. Many believe that the enduring principles of sportsmanship and civility are key reasons the sport has thrived for over 140 years.

Recognizing that periodically reaffirming our shared values strengthens our community, the revised code will be shared widely to highlight the foundational values and principles that define the sport.

- Sportspeople always place the welfare of their dog above all else.
- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.
- Sportspeople are committed to fair play, honesty, courtesy, and competition, approaching both winning and losing with grace.
- Sportspeople understand that strong competition and civility can—and should—coexist. They appreciate the quality of their competitors, and the effort put forth by others.
- Sportspeople uphold their responsibilities to the sport of purebred dogs and refuse to let personal gain or self-interest influence their decisions or behavior.
- The sportsperson judges only on the merits of the dogs and considers no other factors.
- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.

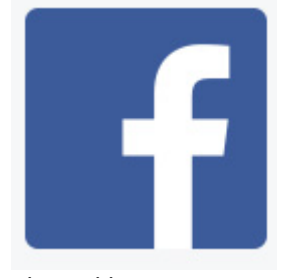

### **Regulations Section 1- Classifications**

Classes will be offered for breeds and varieties and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. The Miscellaneous class competition will be the equivalent of Group competition and the winner will be eligible to compete in Best Four-to-Six Month Puppy in Show.
